GOVERNMENT CONTRACTS

In response to a Senate Order dated 20 June 2001, the Insolvency & Trustee Service Australia (ITSA) provides the following contract information:

- * each contract entered into by ITSA which has not been fully performed or which has been entered into during the 12 months prior to 31 December 2009, & which provides for a consideration of \$100,000 or more;
- * the contractor, the amount of the consideration & the subject matter of each such contract;
- * duration of each contract;
- * whether each contract contains provisions requiring the parties to maintain confidentiality of any of its provisions, & a statement of reasons for confidentiality; &
- * whether any provisions of the contract are regarded by the parties as confidential, & a statement of reasons for confidentiality.

This information is provided for each relevant contract below & the confidentiality arrangements reflect a standard form contract existing at the time & the nature of the contracts in place.
